KEY FINDINGS

After a review of the program and projects it was identified:

- The complex program was in danger of being run in a disparate fashion with isolated and conflicting projects and different project methodologies. This would cause major project overrun and scope issues; the Adventus team advised the RAC to implement a Program Manager and Office to help minimise the impact of these issues;
- Key business requirements needed improved documentation and definition;
- Scope was complex and being informally passed between projects;
- There was a requirement for improved ownership of business processes from an end-to-end perspective - the focus was on silos of technology rather than business processes and benefits;
- There was a lack of effective sponsorship in key project areas resulting in one-sided steering of the program.
